- Providers must comply with the supervision requirements 90 days after the IBHS regulations are promulgated.
- All staff must meet the qualifications in the regulations 90 days after they are promulgated.
- For some staff, there are interim and final qualifications. The final qualifications for staff that provide BHT-ABA services must be met by July 1, 2020.
- The final qualifications for staff that provide BHT services must be met by January 1, 2021.
- The final qualifications for a clinical director of an IBHS agency that provides ABA services must be met by July 1, 2022.
- Initial training requirements are required to be met 90 days after promulgation of the regulation.



#### **OMHSAS** Updates

- New IBHS agencies must obtain a license within 90 days of promulgation.
- Unlicensed entities enrolled under the OMHSAS-16-07 bulletin and approved to provide ABA must obtain a license within 180 days of promulgation.
- IBHS agencies that currently have a base mental health license must obtain an IBHS license when their current license expires.
- All other IBHS agencies approved to provide IBHS must obtain an IBHS license within 1 year of promulgation.
- Annual quality improvement report requirement.

### Code and Modifier Review—Draft codes

- There will be three code sets within the Medical Assistance enrollment Prov. Type/Spec.
  Type. Codes are **not** confirmed but below are proposed:
  - Provider Type 50 with Specialty 590:
    - Individual services
    - Codes being utilized: H0032, H2019, H2021, H2014
    - MST (H2033)
    - FFT (H2019)
  - Provider Type 50 with Specialty 591:
    - Group Services
    - Code H2021 is being utilized for this
  - Provider Type 50 with Specialty 592:
    - Applied Behavior Analysis services
    - Codes being utilized: 97152, 97153, 97154, 97155, 97156, 97158
  - Modifiers have not been finalized but will be utilized



### Magellan Proposed Authorization Process



- Written order language
- Registration process for assessment
- Packet submission elements
  - Treatment Authorization Request (TAR) Form
  - Written order
  - Assessment
  - ITP
  - CANS
  - ISPTM summary note if services prescribed in school



### Magellan Proposed Care Management Approach



- Planning to develop a tiered Care Management approach based on selected metrics
- Potential metrics could include:
  - Authorization data
  - Length of stay data
  - CANS information
  - Acuity
  - Service Completion
  - Others?

Care Management interaction could include the following:

- Telephonic reviews
- Case reviews
- Group Program Management
- Role of the ISPTM

	Requirement
1	Identification and description of each service offered by the IBHS agency
2	Identification of the target population served by each service, including age range and presenting issues, which may include specific diagnoses
3	The days and hours each service is available
4	Identification of the counties where the IBHS agency provides each service
5	Description of admission criteria
6	Description of discharge criteria
7	Description of exclusionary criteria
8	Staffing ratios for each service offered by the IBHS agency
9	Treatment modalities
10	Locations where services are offered
11	Maximum number of children, youth or young adults who will be served at the same time through group services at a community setting or a community like setting



#### **Licensing Process**



- Licenses will be issued regionally
- License will include provider name and types of services (Individual, Group, ABA, EBT)
- If currently enrolled as BHRS or ABA, licensing visit will occur when your current license is set to expire in 2020
- Initial IBHS licensing visit will include the following:
  - Review of Policies and Procedures
  - Physical Site review
  - Staff Structure review
  - Human Resources Record review
  - Chart Audit



### Magellan Proposed Changes

- Magellan will implement a transition process for members currently receiving BHRS as they move to IBHS in accordance with OMHSAS recommendations
- All audit tools will be updated to reflect new IBHS requirements (QI, Compliance, and Network)
- All new contracts will be issued, including new procedure codes



## **OMHSAS IBHS Statewide Trainings**

- OMHSAS is planning several statewide and regional trainings to discuss the forthcoming IBHS regulations. Trainings will include an overview of the regulatory package, instruction on the licensing process, and information sharing regarding timelines and next steps. Anyone interested in, or impacted by, these regulations is welcome to attend.
- OMHSAS is hosting a statewide webinar specific to the IBHS regulations. Registration information for this webinar will be distributed in the near future. The webinar will be held on November 20<sup>th</sup>.
