Updates from OMHSAS



Updates from OMHSAS

- Confirming ORP enrollment: Provider Quick Tip #155 and looking up ORP providers

 Tip gives a link to look up individuals. <u>https://www.dhs.pa.gov/providers/Quick-Tips/Pages/default.aspx</u>
- Pursuant to Act 73 of 2021, the suspension of various regulatory provisions under the state disaster emergency declaration that are currently in effect and which were set to expire on September 30, 2021, are now extended until further notice.
- Reporting requirements are finalized.
- **BSL**-Checklist instructions from the Board of Medicine contained on next few slides.



BSL License Checklist/Instructions

- Application All applications are processed in order of submission. If this application is not completed within six months, updates of certain sections and/or supporting documents will be required. If the application has not been completed within one year from the date it was received, applicants will be required to submit a new application (another application processing fee) and supporting documents, as necessary.
- Application Fee An application fee of \$75.00 is required. Please note that all fees are non-refundable.
- Child Abuse CE All health-related licensees/certificate holders and funeral directors are considered "mandatory reporters" under section 6311 of the Child Protective Services Law (23 P.S. § 6311). Therefore, all persons applying for issuance of an initial license or certificate from any of the health-related boards (except the State Board of Veterinary Medicine) or from the State Board of Funeral Directors are required to complete, as a condition of licensure, 3 hours of approved training by the Department of Human Services (DHS) on the topic of child abuse recognition and reporting. After you have completed the required course, the approved provider will electronically submit your name, date of attendance, etc. to the Bureau. For that reason, it is imperative that you register for the course using the information provided on your application for licensure/certification. A list of DHS-approved child abuse education providers can be found on the Department of State Website.



BSL instructions continued...

- Child Abuse History Clearance Contact the Department of Human Services or equivalent agency for each state in which you currently reside or work and have resided or worked during the previous 10 years and request a Child Abuse History Clearance be completed.
- Clinical Experience- Complete Section 1 of the Verification of Clinical Experience form (Form 4) and forward to your previous/current employer or clinical supervisor for completion of Section
 The employer or supervisor must verify completion of at least 1,000 hours of in-person experience with individuals with behavioral challenges or autism spectrum disorders. The verification form must be completed and returned directly to the Board from the employer or clinical supervisor. The form will be available for download and printing when the application is submitted.
- Databank Report- Provide an official notification of information (Self Query) from the National Practitioner Data Bank. Please refer to the NPDB website for additional information. When you receive the "Response to your Self Query," you will need to upload it to your online application. The report will need to be uploaded, where prompted, in order to submit your application.
- Federal Bureau of Investigation (FBI)- Contact the Federal Bureau of Investigation (FBI) to obtain an FBI Criminal Background Check at https://www.fbi.gov/services/cjis/identity-historysummary-checks. The Board will accept the official FBI Report or a report from an official FBI approved Channeler. A list of approved channelers can be found at https://www.fbi.gov/services/cjis/identity-history-summary-checks/list-of-fbi-approvedchannelers-for-departmental-order-submissions.



BSL instructions continued...

- Functional Experience Complete Section 1 of the Verification of Behavior Assessment Experience form (Form 3) and forward it to your previous/current employer or clinical supervisor for completion of Section 2. The form must verify the completion of at least one year of experience involving functional behavior assessments of individuals under 21 years of age, including the development and implementation of behavioral supports or treatment plans. The verification form must be completed by the applicant's employer or clinical supervisor and returned directly to the Board from the employer or supervisor. The form will be available for download and printing when the application is submitted.
- Letter of Good Standing (LOGS) Contact the licensing authorities of the states, territories or countries where you hold or have ever held a license, certificate, permit, registration or other authorization to practice a health-related profession (whether active, inactive, expired or current) and request letters of good standing/verification of licensure in that state or jurisdiction. The letter must include the following: license issue and expiration date, license status (current or expired) and disciplinary standing. The letter(s) of good standing must be sent directly to the Board.
- National Certification Contact the BACB (Behavior Analyst Certification Board) and request a BACB Letter of Good Standing for your certification as a Board-Certified Behavior Analyst (BCBA) or Board-Certified Behavior Analyst—Doctoral (BCBA-D) to be sent directly to the Board.



BSL instructions continued...

- Resume Curriculum Vitae Please upload a Curriculum Vitae/Resume listing all periods of employment or unemployment (i.e., child rearing, research, etc.) from graduation of undergraduate to present (the education completed which qualifies you for this license). The list must be in chronological order, including the name, city and state of the employer, dates of employment or advanced education/training (include the month and year), and description of the practice activity.
- State Police Criminal History Check Contact the state police in which you currently reside or work and have resided or worked during the previous 10 years and request a Criminal History Record Information Report (CHRI) be completed.

Per Provider report from Access Surveys:

• Individual services: 130 referrals in Q3. 53 started services. 54 discharged.

Subsidized Child Care



Title 55 CHAPTER 3041. SUBSIDIZED CHILD CARE ELIGIBILITY



§ 3041.11. Nondiscrimination.

(a) An eligibility agency may not discriminate against applicants for or recipients of Federal or State subsidized funds on the basis of age, race, sex, color, religious creed, national or ethnic origin, ancestry, sexual preference or **physical or mental** disability.

(b) An eligibility agency shall offer childcare subsidy within the provisions of applicable civil rights laws and regulations, including the following:

- (1) The Pennsylvania Human Relations Act (43 P. S. § § 951—963).
- (2) The Age Discrimination Act of 1975 (42 U.S.C.A. § § 6101—6107).
- (3) Title VI of the Civil Rights Act of 1964 (42 U.S.C.A. § § 2000d-2000d-4a).
- (4) Title VII of the Civil Rights Act of 1964 (42 U.S.C.A. § § 2000e-2000e-15).
- (5) Section 504 of the Rehabilitation Act of 1973 (29 U.S.C.A. § 794).
- (6) The Americans with Disabilities Act of 1990 (42 U.S.C.A. § § 12101—12210).

The Americans with Disabilities Act: Chapter 126 - Subchapter II - Public Services



The term "public entity" means

- (A) any State or local government;
- (B) any department, agency, special purpose district, or <u>other instrumentality of a State or</u> <u>States or local government</u>; and
- (C) the National Railroad Passenger Corporation, and any commuter authority (as defined in section 24102(4) of title 49).

The term "qualified individual with a disability" means an individual with a disability who, with or without reasonable modifications to rules, policies, or practices, the removal of architectural, communication, or transportation barriers, or the provision of auxiliary aids and services, meets the essential eligibility requirements for the receipt of services or the participation in programs or activities provided by a public entity.

Sec. 12132. Discrimination

 Subject to the provisions of this subchapter, <u>no qualified individual with a disability shall</u>, <u>by reason of such disability</u>, <u>be excluded from participation in or be denied the benefits of</u> <u>services</u>, <u>programs</u>, <u>or activities of a public entity</u>, <u>or be subjected to discrimination by any</u> <u>such entity</u>.

Barriers to Access for Children with Disabilities

- Serving children with special needs can require providers to invest in specialized staff training and equipment.
- Providing accommodations can represent a significant financial investment for providers, especially small centers.
- Potentially risky business decision given high turnover rates and uncertain or unreliable demand
- To keep costs manageable, providers may also target services to children with less severe caregiving needs, bypassing families requiring more specialized (and costlier) services.
- Providers may be hampered by a lack of confidence and uncertainty in their ability to care for children with disabilities, especially if they have limited experience or familiarity with this population
- Parents encounter an unwillingness and a lack of provider training related to delivering appropriate services for children with disabilities and special needs
- Centers are more likely than licensed family homes to serve children with disabilities, especially large centers with the financial capacity to invest in necessary staff training and equipment

Daycares May Not Exclude a Child Based on a Menta Health Diagnosis



- Decisions about Medical Necessity for BHT–ABA or BHT services in a Daycare setting may not be based on the facility request for BHT support.
- If parents request BHT services in a Daycare setting based primarily on the child's mental health diagnosis

AND

- Without a trial period or reasonable accommodations
- Parents should be referred to Disability Rights PA (215-238-8070)
 - Parents can call between 9-3 and you get to speak to a lawyer,
 - The parent needs to call because they handle this issue on a case-by-case basis.
 - It is certainly OK for a BC to facilitate the call.

Clinical Updates & Reminders



Psychiatric Rehabilitation

Psychiatric rehabilitation can help successfully integrate young adults with ASD in the community through skills teaching.

Strengths-based service providers collaborate with the individual with ASD and their circle of care to develop a plan. Adult daily living skills are taught. Natural supports and resources are strengthened. Services further education, jobs, communication, socialization, wellness management, as well as managing living successfully in an environment of choice.

Program Eligibility

- Member with Medicaid insurance.
- Ability and willingness to independently participate in choice-based planning.
- 18 years or older or meet the age criteria established by OMHSAS for young adults.
- Have a written recommendation by a licensed practitioner of the Healing Arts -Physician (MD, DO), Certified Registered Nurse Practitioner (CRNP), Physician's Assistant, Licensed Psychologist, Licensed Clinical Social Worker (LCSW), Licensed Marriage & Family Therapist (LMFT) or Licensed Professional Counselor (LPC).
- Identified need in at least one life domain (Living, Learning, Working, or Socializing).



Psych Rehab continued...



Program Facts

- Designed for young adults, ages 18+.
- Teaches skills in Living, Learning, Working and Socializing. Individual choice is maintained in addressing the skills needed.
- Staff provide direct and indirect skills teaching inclusive of cooking, cleaning, menu planning, shopping, money management, physical & mental wellness management, communication, and/or furthering interest leading to meaningful employment.
- Services provided in the home, community (Mobile) or licensed facility (Site-Based). Delivered on a one-to-one basis or in small groups.

The Written Order is valid for 1 year from the date it was completed. This includes Written Orders previously recommending both BHRS and IBHS (dual language). Providers must submit a valid Written Order with each authorization packet request.

Ex. Face-to-Face Written Order completed on 2/1/2020. Initial services started 1/15/2021. Authorization is for 1/15/2021-7/13/2021. For the reauthorization in July 2021, a new WO is needed as the WO is no longer valid.

Ex. Face-to-Face Written Order completed on 2/1/2020. Initial services started 3/1/2020. Authorization is for 3/1/2020-8/27/2020. For the reauthorization in August 2020, a new WO is NOT needed as the WO is still valid until 1/31/21.



Do we need to do a new evaluation every 6 months?



• No. Written Orders are required to be completed once a year. If providers are using psychological evaluations as Written Orders, the same timeframes apply.





Your agency completed the initial assessment; prepared and submitted the initial packet for MNC review to Magellan.

Does my agency need to update the Written Order?

• If necessary, we would request assistance with getting a new Written Order if it will be expiring soon.

Does my agency have to do a new assessment in 6 months if no provider is found?

• No. We would request the new provider once identified seek to complete an updated assessment to ensure the treatment plan needs are still appropriate.



Extension Requests



- Magellan has been seeing a significant increase in extension requests.
- As noted previously, Written Orders are good for 1 year so please ensure your agency is backing into this for concurrent packets.



CANS Reminders



A CANS is required within all initial and concurrent packets for any member 3 years or older. Within BHRS, it was not required in the initial packets and the clinician was given 30 days to complete it. However, within IBHS, there is more time on the front end during the assessment to complete this.



Quick Reminders



- Please check and make sure that the specific service and amount of hours per month <u>in</u> <u>each setting</u> is listed in the Written Order recommendations, Assessment recommendations, and Individualized Treatment Plan.
- Packet errors have been very high. It results in a lot of time by the provider and Magellan to adjust/clarify this during the packet review process. Please consider supervisor oversight if there are consistent packet error submissions for further assistance.
