

# Provider FAQ for Somerset and Bedford Counties – As of October 17, 2025

Note: Magellan Behavioral Health of Pennsylvania, Inc. (Magellan) is working together with Behavioral Health Services of Somerset and Bedford Counties (BHSSBC) on this implementation.

#### 1. When is the "Go Live" date?

November 1, 2025.

### 2. When will the updated provider handbook be available?

 The updated provider handbook will be posted on the Magellan website with BHSSBC information by late-October.

# 3. What can I expect during the credentialing/contracting process with Magellan and BHSSBC?

- If you are already participating with Magellan, and the service location holds current Magellan credentialing, you will receive an amendment to add the location(s) to Somerset and Bedford Counties with codes/rates that reflect your current contracts.
- If any location is not credentialed with Magellan, you will receive a credentialing application for each rendering service location that will need to be contracted. Once credentialing is complete, you will be issued a contract amendment or full contract depending on your current participation with Magellan.
- Magellan will process clean submitted credentialing applications within 60 days.
- You may require a site visit to complete credentialing if the location does not hold a license or accreditation. A Magellan representative will outreach you to schedule.
- When the contract is complete, you will receive a welcome letter from Magellan with information on getting set up in the Magellan secured website (<u>Magellan Health, Inc. |</u> <u>Providers | User Sign In</u>).
