



# Provider Implementation of Screening Codes for Tobacco and Suicide Safety Planning

The Center for Medicare and Medicaid Services (CMS) has established various core data set measures that states must report to CMS. The Pennsylvania Department of Human Services Office of Mental Health and Substance Abuse Services (OMHSAS) issued a bulletin on April 15, 2025, entitled [Screening for Tobacco Use G-Codes and Suicide Safety Plan M-Codes](#).

To support performance measure monitoring and oversight for the OMHSAS Quality Management Tobacco Recovery Quality Initiative and OMHSAS Performance Improvement Project (PIP), OMHSAS requires Magellan Behavioral Health of Pennsylvania (Magellan) to collect both tobacco use screening data (via G Codes through claims submissions) as well as suicide safety plan data (via M Codes through claims submissions).

The following Current Procedural Terminology (CPT) and Healthcare Common Procedure Coding System (HCPCS) codes have been added to the Behavioral Health Services Reporting Classification Chart (BHSRCC) for dates of service on or after January 1, 2025. Many of these codes are informational. Please reference the BHSRCC for applicable provider type and specialty limitations. Magellan requests that providers begin submitting G Codes for tobacco screening and M Codes for suicide safety plans per the specification of this notice, effective immediately.

Tobacco-related diagnoses should be documented in the member's medical record and within claims consistent with the Diagnostic and Statistical Manual of Mental Disorder, Fifth Edition (DSM-5™).

## Tobacco Screening Codes

G Code	Code Description
G9902	Patient screened for tobacco use AND identified as a tobacco user
G9903	Patient screened for tobacco use AND identified as a tobacco non-user
G9905	Patient not screened for tobacco use
G9906	Patient identified as a tobacco user received tobacco cessation intervention during the measurement period* or in the six months prior to the measurement period (counseling and/or pharmacotherapy)
G9908	Patient identified as a tobacco user did not receive tobacco cessation intervention during the measurement period* or in the six months prior to the measurement period (counseling and/or pharmacotherapy)

	M1353	Patients who did not have a completed suicide safety plan initiated, reviewed, or updated in collaboration with their clinician (concurrent or within 24 hours) of the index clinical encounter
	M1354	Patients who did not have a suicide safety plan initiated, reviewed, or updated in collaboration with the patient and their clinician (concurrent or within 24 hours) of clinical encounter, and within 120 days after initiation
	M1355	Suicide risk based on their clinician's evaluation or a clinician-rated tool
	M1356	Patients who died during the measurement period*
