

# The benefits of Behavioral HealthChoices

In Harrisburg, Senate Bill 268 (SB 268) and House Bill 335 (HB 335) call for the elimination of the Behavioral Health Carve-out, known as Behavioral HealthChoices (BHC). Magellan leadership has reviewed SB 268 and HB 335, and strongly opposes these bills. Carving behavioral health services into physical health managed care does not translate into better health outcomes and it will not save taxpayers' dollars in the short or long run.

As a Behavioral Health Managed Care Organization (BH-MCO), that maintains a strong presence within our communities we serve, we have worked closely with our county partners and the Department of Human Services since the inception of BHC in 1997 to improve access and the quality of behavioral health services. Collectively we should take pride in BHC's mission-focused philosophy that demands a collaborative, coordinated and consistent service delivery model for our Members. I witness this each and every day, and most appreciate the intricate levels of support that are vital for Members with complex challenges. SB 268 and HB 335 are threats to these day-to-day needed services.

With all of our Members in mind, it is critically important that we remain focused on our following objectives:

- To further develop and refine value-based reimbursement models.
- To continue our integrated health initiatives focusing on whole health and provider communication.
- To create additional solutions to address the opioid epidemic.
- To support transition-age youth and young adults.
- To ensure that reinvestment expenditures go to the highest need in our counties.

We need to remember that BHC was created 22 years ago because Members were not receiving adequate levels of care under the fee-for-service model.
